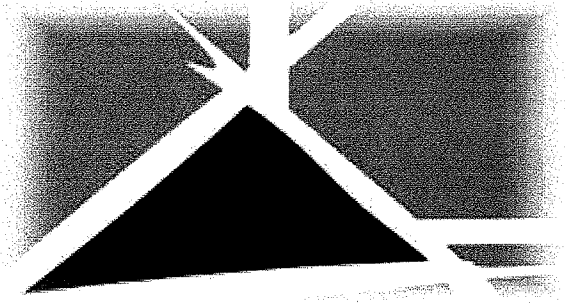

The Derrel Dee Webb Lifetime Service Award was established in 2005 pursuant to action taken by the Board of Directors of the Sionito Campgrounds Association. The award spotlights and honors individuals who have dedicated their lives to outstanding service to Camp Sionito.

Saluting Outstanding Service to Camp Sionito

On the Sunday of both First and Second Community of Christ Reunions the Board of Directors of the Sionito Campgrounds Association will host a reception honoring Camp Sionito donors and volunteer workers. During the reception, the Board will recognize one or more individuals who have dedicated their lives to outstanding service to Camp Sionito. We encourage you to nominate one or more individuals who you believe have provided a lifetime of outstanding service to Camp Sionito.

Rationale

The award is intended to honor those who have made outstanding contributions in the past and foster continued support for the campgrounds in the future.

Eligibility

Nominees must have contributed a lifetime of outstanding service to Camp Sionito. Although it is preferred that nominees be present to receive their awards, this is not a requirement for nomination or final selection.

Sponsoring Organization

The Sionito Campgrounds Association was organized to develop, maintain and operate Camp Sionito, a conference and retreat center which provides a camp setting including appropriate indoor and outdoor facilities to accommodate children/youth camps, reunions, leadership training events, retreats, conferences, and special needs/interests activities.

Screening Committee

A committee will be appointed by the President of the Board of Directors of the Sionito Campgrounds Association to review nominations. Members of the Screening Committee will be appointed exclusively from the Board of Directors of the Sionito Campgrounds Association. The Board of Directors of the Sionito Campgrounds Association will ultimately select the recipients of the award at its Spring meeting based upon the recommendation of the Screening Committee.

Multiple Nominations

You may nominate more than one person to receive the award. Please fill out separate nomination forms for each nominee. Nominations must be submitted on the official Derrel Dee Webb Lifetime Service Award Nomination Form.

Contribution Summary

Describe the outstanding contributions made by your nominee to Camp Sionito. Please include relevant biographical material about your nominee in this one-page description. You may submit up to one additional page of detailed accomplishments.

Supplemental Materials

You may include supplemental materials, but it is not necessary. Supplemental materials may include photos, letters of recommendation, camp logs or other relevant historical documents. Supplemental materials will not be returned.
